**THE TRIBUNAL HEARS AND DECIDES APPEALS AND APPLICATIONS IN RELATION TO CHILDREN AND YOUNG PEOPLE WHO HAVE OR MAY HAVE ADDITIONAL LEARNING NEEDS (ALN).**


**SPECIFICALLY, IT HEARS AND DECIDES APPEALS ABOUT THE DECISIONS OF AN FEI OR A LOCAL AUTHORITY IN WALES  
THE TRIBUNALS DECISIONS ARE LEGALLY BINDING.**

**A PARENT CAN MAKE AN APPEAL TO THE SPECIAL EDUCATIONAL NEEDS TRIBUNAL FOR WALES (SENTW) AGAINST CERTAIN DECISIONS MADE BY A WELSH LOCAL AUTHORITY ABOUT THEIR CHILD'S ALN. THE TRIBUNAL MAY REQUIRE A LOCAL HEALTH BOARD TO PROVIDE EVIDENCE AND CAN MAKE RECOMMENDATIONS TO THE HEALTH BOARD.**

**CHILDREN AND YOUNG PEOPLE CAN ALSO MAKE AN APPEAL BY TELLING THE TRIBUNAL THAT THEY DISAGREE WITH A DECISION ABOUT THEIR EDUCATION.**

**CHILDREN AND YOUNG PEOPLE CAN ASK AN ADULT TO HELP FILL IN THE APPEAL APPLICATION FORM. IF THEY HAVE SOMEONE TO HELP THEM, THE NAME FOR THIS PERSON IS A 'CASE FRIEND'. THE CASE FRIEND MUST TELL/INFORM THE TRIBUNAL THAT THEY ARE HELPING.**

**THE PROCESS OF DEVELOPING AN INDIVIDUAL DEVELOPMENT PLAN (IDP) WHICH MAKES SURE THE VIEWS, WISHES AND FEELINGS OF YOU AND YOUR CHILD OR YOUNG PERSON ARE REPRESENTED, HELPS TO OVERCOME CONCERNS AND PREVENT DISAGREEMENTS FROM ARISING.**

**EARLY RESOLUTION OF ANY DISAGREEMENTS IS BEST FOR EVERYONE AND CAN HELP TO AVOID STRESS.**

**IF YOU ARE UNABLE TO AGREE ABOUT DECISIONS OR PROVISION, INDEPENDENT PARENT PARTNERSHIP SERVICES PROVIDED BY THE LOCAL AUTHORITY CAN SUPPORT YOU**
